

INTRODUCTION

The interdisciplinary online advanced course about Collaborative Housing that we present is part of the international research project CO_HOPE: Collaborative Housing in a Pandemic Era¹ carried out by five European countries (Austria, Spain, France, Finland and Sweden). It is defined within the WP6 work package whose main objective is to disseminate and transfer the project's learning through didactic formats and contents. In this sense, it aims to develop a training programme for a diverse spectrum of actors involved and interested in collaborative housing projects (university students, researchers, professionals and social agents) in order to expand this model of collaborative habitat production and management. This programme includes, in addition to this interdisciplinary online course, seminars for professionals and dissemination events aimed at the general public in order to open up avenues of innovation in collaborative social habitat issues.

Collaborative housing in Europe has different historical origins, purposes, building forms, scales, forms of tenure, types of residents, access to resources, organisational models, degrees of community self-management or institutionalisation. The CO-HOPE project addresses these issues from a transnational and interdisciplinary approach, involving universities, residents and agents related to the development of housing models (municipalities, non-profit organisations, architectural firms, residents' associations).

The project has studied the general characteristics (differences and similarities) of 14 case studies selected in the five participating European countries, as well as the mechanisms that have allowed or limited their development from the interrelation of the triple nexus of housing affordability-social integration-health.

On the other hand, it addresses the Right to the City, the role of public policies in promoting the model and the role of participatory processes for the design and development of collaborative housing communities.

OBJECTIVES

This course aims to be a practical training whose purpose is to contribute (from the cases studied) to new formulas for the relationship between Housing, City and Citizenship that can be a factor of resilience in the face of crisis situations.

The main objective is to contribute to the production and social management of collaborative housing in an integrated way and to create capacities that promote the development of collaborative housing (CH from now on). Its design is focused on reflecting on the resilience of CH in crisis situations such as COVID from the triple nexus between: housing affordability-social integration-health but also how this housing model contributes to the Right to the City with very valuable contributions in sustainability, self-organisation, participatory design, quality of life and community life based on mutual support. As specific objectives of the interdisciplinary course:

- 1. Understanding collaborative housing from the perspective of the CO-HOPE project and the triple nexus: housing affordability-social integration- health.
- 2. Identifying and conceptualizing the multidimensional, multifactorial and transdisciplinary nature of collaborative housing from the Right to the City and integral and complex way.
- 3. Understanding how collaborative housing projects work in the consortium countries of CO-HOPE (Austria, France, Spain and Sweden) and transferring what has been learned to others collaborative housing projects.
- 4. Contributing to the formulation of tools that are applicable to the local contexts of the participants based on key findings of the CO-HOPE project.

The course will provide participants with the following competencies:

- 1. To address collaborative housing processes from complex perspective considering the interrelation of multiple factors (physical, social, cultural, economic and political)
- 2. To develop diagnoses and proposals for collaborative housing in a participatory, and integrated way (from a multidimensional, intersectoral and multiagent approach)
- 3. To be able to understand the phases of participatory processes for the development of a collaborative housing community to be applied in future.
- 4. To be able to use participatory management tools for the different stages and steps to be followed in the development of collaborative housing communities.



WHO IS THE TARGET AUDIENCE

The course is targeted at all the agents involved in the process of developing a collaborative housing. Furthermore, emphasising the idea of a socially engaged university, involving people related to education, research and social transformation through the transfer of knowledge, members of the Academia are also considered part of the target group.

Social actors: participants in collaborative housing, housing activists, CH communities, etc.

Professionals: technical and political practitioners of housing development, technical support experts of cohousing with an interdisciplinary profile.

Academia: university students (last year of bachelor and master), PhD students, postgraduate scholars, university lectures and researchers

ORGANISATION AND STRUCTURE

DELIVERY OF THE COURSE

Mode of delivery: Online

In order to have a good interaction during the class, the virtual platform of the University of Seville will be used, in which spaces for teamwork can be set up for the activities to be developed in the workshop

Duration: 40h spread over 10 sessions (20 November 2024 - 5 February 2025).

Schedule: one session per week (4h), on Wednesday afternoons (16-20h)

Language: English, French and Spanish with simultaneous translation.

Credits: 4 ECTS (in soft pipeline)



ACCESS REQUIREMENTS

The course has an interdisciplinary approach, so the profile to which it is addressed and the order of presentation of the pre-enrolment application will be considered.

Enrolment fee: Access and registration are free of charge.

EVALUATION

At least 80% attendance, active participation in the sessions and the handing in of the class notebook at the end of the course will be assessed



CONTEND OF SESSIONS

The content of the course is organised in 2 blocks, from a general perspective (illustrated with the CO-HOPE case studies) to a more concrete one. The first block (sessions 1-5) focuses on contextualising collaborative housing from the international perspective of CO-HOPE, based on the key findings from the project's case studies. It will also conceptualise the complex approach to collaborative housing situations. The second block (sessions 6-10) deals with topics related to the management and development of collaborative housing communities.

The course will consist of **40 hours in total during 10 weeks** that will be adapted to the calendar. The teaching team responsible for the course will be composed of the members of the CO-HOPE consortium and experts on the topics to be addressed in each session and the supervision of the students' work.

Contents of the sessions

- The CO-HOPE project. Conceptual framework, triple nexus: affordability-social integration-health and transdisciplinary approach.
- Context of housing and its complex relationship with social housing and the Right to the City.
- Strategic policy frameworks to promote collaborative housing in European contexts.
- The role of participatory technical assistance. Transdisciplinary technical support and accompaniment teams for collaborative housing processes.
- Participatory design and common spaces.
- Managing multi-stakeholder processes. Building governance spaces.

METHODOLOGY

Each session will consist of two parts. On the one hand, presentations by members of the CO-HOPE team and invited experts who reflect on the issues and actions from the lessons learned from the 14 case studies of the project. The second part, in the format of workshops on topics of high interest for facilitating collaborative housing processes, which aims to involve participants in a multi-agent debate and joint work.

1. Content exposure / case study analysis / Discussion, Q&A (2h).

2. Break (15 min)

3. Workshop. Work will be carried out in a group workshop format (US dynamization and facilitation), elaborating the proposed exercise (1h 45 min)
